Updated ACE Transition Timeline

U.S. Customs and Border Protection (CBP) continues to assess stakeholder readiness for the mandatory transition of post-release capabilities in ACE. As a result, CBP has rescheduled the October 29, 2016 ACE transition date. This transition includes the mandatory use of ACE for liquidation, drawback, reconciliation, duty deferral, collections, statements, and the Automated Surety Interface. CBP is targeting January 2017 for the revised deployment and mandatory date and will provide additional clarification regarding the precise transition date in the coming weeks.

All capabilities included in this transition that CBP planned for the Certification environment (CERT) are operational in CERT. CBP encourages trade users to take advantage of the additional time to test their software fully. CBP also encourages the trade community to continue to participate in ACE Partner Government Agency (PGA) pilots. PGAs will provide additional information regarding the conclusion of their pilots as appropriate.

While CBP has implemented the capability for most PGA data to be filed electronically in ACE, trade users may continue to file a combination of CBP electronic data and PGA paper forms where that is currently permitted.

- Animal and Plant Health Inspection Service (APHIS) Lacey Act, National Highway Traffic Safety Administration (NHTSA), Food and Drug Administration (FDA) and National Marine Fisheries Service (NMFS) data is required to be filed electronically in ACE.
- For PGA data that is not required to be filed electronically in ACE, filers may file using options currently specified as available for those PGAs.
- CBP will continue to coordinate and communicate as required the conclusion of PGA pilots via public notices.

UPDATE ON AUGUST 27 MANDATORY USE DATE

On August 27, 2016, CBP deployed new functionality to ACE for filing and processing electronic protest transactions. CBP also enhanced the ACE Secure Data Portal to include a new Protest Filer Account view for the trade community that supports broader participation and will increase the number of electronic protests filed in ACE.

Following the deployment, CBP disabled all protest filing and processing capabilities in the Automated Commercial System (ACS). As a result, all electronic protest filers will now file all electronic protests via the ACE Portal, and will discontinue using the Automated Brokers Interface (ABI) to submit electronic protest information to CBP. This transition will not impact filers who submit paper protests on the CBP Form 19; CBP will continue to accept paper-based protest transactions. However, all electronic protests are given a priority status and processed faster than protest transactions submitted via paper.

CBP published a series of Federal Register Notices (FRN) to announce the transition of electronic protest filing in ACE, requirements for establishing a Protest Filer account in the ACE Portal, and details concerning the commencement of the National Customs Automation Program (NCAP) test for electronic protest filing in ACE. The FRNs include:

Additionally, CBP published an online <u>Protest Information Notice</u>, a video on <u>How to Request a Protest Filer Account</u>, a <u>Protest Demonstration Webinar</u> and a <u>Protest for Trade Quick Reference Guide (QRG)</u>. These materials provide guidance on establishing a Protest Filer account, getting started with protest filing, making an accelerated disposition claim, receiving protest status updates, locating points of contacts for protest questions and additional areas of protest filing in ACE.

UPDATE ON JULY 23 ACE MANDATORY USE DATE

On July 23, 2016, nine additional entry types were successfully deployed in ACE. Electronic entry and entry summary filing for the entry types below is now mandatory in ACE, regardless of PGA requirements:

- 02 Consumption (Quota/Visa)
- 07 Consumption (Antidumping/Countervailing Duty and Quota/Visa)
- 12 Informal (Quota/Visa other than textiles)
- 21 Warehouse
- 22 Re-warehouse
- 31 Warehouse Withdrawal (Consumption)
- 32 Warehouse Withdrawal (Quota)
- 34 Warehouse Withdrawal (Antidumping/Countervailing Duty)
- 38 Warehouse Withdrawal (Antidumping/Countervailing Duty and Quota/Visa)

FREQUENTLY ASKED QUESTIONS

What do I enter as my Shared Secret to retrieve a password to access my ACE Portal Account?

A Shared Secret is a passphrase used to authenticate a user's identity. Below is a table listing Shared Secret values assigned to ACE Portal Account users based on their account role:

Account Type	Default Shared Secret	
Trade Account Owners (TAO) (All account types except Exporter)	Unique assigned value	
TAO (Exporter)	Account ID	
Proxy or Trade Account Users (For all account types)	Account ID

TIP OF THE MONTH

Electronic Protest Information Available in ACE Reports

Brokers and Importers can modify Entry Summary Management (ESM) reports and add a data object to obtain the status of a Protest filed for an ACE Entry Summary. To modify an ESM report and include the "Protest Status" data object, please note the following steps:


1. Switch from "Reading" to "Design" mode from inside the standard ESM report.



2. Click on the "Edit Data Provider" icon or the "Edit" icon from the "Data Access" and "Data Providers" tabs.




3. Add the "Protest Status" data object from the **Summary Header > Status** sub-class folder in the "Universe Outline" panel and drag it to "Result Objects" located in the Query Panel dialogue box, then click on the "Run Query" button.



4. Complete the Prompts and click on "OK" to run the report.



5. Once results display in the report, please drag the "Protest Status" data object from the "Available Objects" panel to the table in the report.
